Unfinished Business

1. Proposed Amendments to the Urban Village Mixed Use Overlay Parking Regulations – Ch. 17.21 SWMC (2nd Read). Planning Director John Coleman had a discussion with Councilmembers regarding the changes requested at the last meeting. Councilwoman Kesti made a motion to adopt Resolution 1099-22 to deny the requested amendments to the parking requirements in the Urban Village Mixed Use Overlay regulations in Chapter 17.21 SWMC. Motion was seconded by Councilmember Diamond. Motion carried (6-0).

A motion was made by Councilmember Lavacca, seconded by Councilmember Burns to authorize the Mayor to sign the proposed Change Order 30 to Agreement 2021-PW-02 with Faber Construction. Motion carried (6-0). There was also a motion made by Councilmember Allen, and seconded by Councilmember Lavacca, to authorize Public Works Director Mark Freiberger to direct the Contractor to proceed with the work under PCO-030. Motion carried (6-0).
- 2. First Amendment to Agreement with Thompson, Guildner & Associates for Prosecution Services. First Read, no action taken at this meeting.

- 3. Sole Source Declaration and approval of Purchase Order 2022-PO-12 WWTP Rotary Screen Spiral Assembly Replacement. Councilmember Kesti made a motion, seconded by Councilmember Diamond, to approve Resolution 1094-22 waiving competitive bidding requirements and authorizing Public Works Director Mark Freiberger to issue Purchase Order 2022PO12 for the replacement of the wastewater treatment plant spiral screw. Motion carried (6-0).
- 1. Public Hearing and First Reading 2023-2028 Transportation Improvement Program. Public Works Director Mark Freiberger presented information regarding the Program and much discussion followed with Councilmembers asking questions and getting clarification. This is a First Read only and no action was taken during this meeting.
